Charlene has served as a volunteer advocate in Delaware County for two years. During that time, she has been able to expand her understanding of what CASA does and has learned so much. She has seen a change for the better, even in the life of the mother of the child whose case she worked on. She has also gained an appreciation of all the people who work every day with CASA of Northeast Oklahoma.

More services = 100% of respondents

Fewer services = 0% of respondents

The same service = 0% of respondents

I have a better understanding of what is happening in a case when a CASA is appointed:

Strongly Agree = 83.33% of respondents

Agree = 16.67% of respondents

The information included in the reports I receive from CASA meets my expectations:

Strongly Agree = 100% of respondents

I feel the needs of the children are better met while they are wards of the court when they have a CASA:

Strongly Agree = 100% of respondents

"Since CASAs generally have no more than 2 or 3 cases, they are able to observe issues children are having by spending more time in the foster home and the parents' homes and more time observing visitations and talking with foster parents and counselors." - Juvenile Deprived Judge
